##### Information on the Contractor's protection instruments

If the policyholder and/or the insured party is not satisfied with the outcome of the complaint, or if no response is received within 45 days from the receipt of the complaint, the policyholder and/or the insured party may contact Ivass – Institute for Insurance Supervision- Via del Quirinale 21 - 00187 - Rome, attaching the documentation relating to the complaint handled by the intermediary, as indicated in the additional DIP.

- that the policyholder has the right to apply to the Judicial Authority, or to use the out-of-court dispute resolution systems provided for by current legislation, as indicated in the additional DIP;
- that the policyholder has the right to apply to the Guarantee Fund for Insurance and Reinsurance mediators, located at Consap, Via Yser 14, 00198 Rome, telephone: 06/85796538 E-mail: [fondobrokers@consap.it](mailto:fondobrokers@consap.it) to request compensation for financial damage caused to them by the intermediary activity, which has not been compensated by the intermediary itself or through the policy referred to in the previous point.
